



Halkee ayan ka kiraysan karaya guri?

Meelo badan aya jirta oo laga kiraysan karo guri. Waxa lagu soo qora jariiddada, waxa jira website ay ku qoran yihin dad doonaya inay guri kireyaan ama qof ay la qaybsadan. Laba aya ugu caansan, waa kuwan magacyadoodu: www.daft.ie iyo www.myhome.ie

Imisa nooc ayay u kala baxaan guryaha la kiraystaa?

Guryaha la kiraystaa way badan yihin. Qaar way balaadhan yihin, house aya la yidhaahda, qarna guryo kooban weeyan, waa foq dad wada galan. Qaarna waa guryo casri ah, oo loo yaqaano af ingiriiska apartment.

Waa maxay guryaha la yidhaahdo bedsit?

Bedsit waxa la yidhaahda, meel makhsinka la seexo iyo makhsinka fadhigo isku mid yihin. Jikadu ama madbaku iyo beitelmeigu way kooban yihin.

Miyaan u bahanahay inaan soo qado finijar ama alaab?

Guryuhu inta badan way alaabeysan yihin, alaab kooban aya taala. Laakin waa la heli kara guri anaan alaabeysneyn.

Goorma aya la bixiya kirada?

Inta badan waxa lagu bixiya bil, laakin waxa ay ku xidhantay qofka aqalka kaa kireeyey.

Liiska ama af Ingiriiska Lease maxa la yidhaahda?

Liisku waa heshiis dhex mara ama ay kala sexeexdaan qofka guriga kiraysa iyo qofka guriga leh. Waa warqaad sharci. Wa inay ku qornaadan waxyaabo ay ka mid yihin:

- Magaca qofka kiraysanaya iyo magaca qofka kiraynaya
- Inta ay kiradu tahay
- Adreska u gurigu ku yaalo
- Muddada kiradaas ay soconayso
- Alaabta taala iyo wuxi kale guriga laga helo.

Buggu kiradu wa maxay?

Wa buug ay waxa kor ku qooraan oo dhan ay ku yaalan, iyo kirada aad bixiso bilwalba. Xeer ayaad u leedahay, qofka guriga kaa kireyey inu ku siiyo.

Maxa la yidhaahda dhiiposit?

Waa lacag bil kiradeed u dhiganta (way ka badnaankarta) oo aad ku khasban tahay inaad dhigto marka aad aqal kiraysanayso. Qoofka aqalka lihi wu ku dhigaya waanu ku celinaya marka aad ka baxayso guriga, hadi aadan wax dhibaato ah gaadhsiin guriga. Hadi aad adigoon ogaysiis si bixin aad ka bax do guriga, lacagta waa laga haysanay.

Maxa dhacaya haddi ay ilaa noqoto inuu qofkaan aqaalka ka kiraystay si xun ilaa dhaqmo?

Haddi aad dareento inuu qofkaad aqalka kaga jirta guriga aanu si wacan ka dhigin waxaad la hadli karta dawlada hoose.

Waxa jirta waxyaabo ah inuu guriga yeesho. Sharciy cusub aya soo baxaya (2009) oo ku dadaalaya sidi ay guryuhu intaa kooban guriga laga rabo inuu yeesho.

GURYAHA QOFKU ISAGU LEEYAHAY

Maxa jira haddi aan doonayo inaan guri ama apartment iibsada?

Guri iibsigu Ireland waa qaali. Guryaha intooda badan waxa laga iibsada dad la yidhaahdo estate agents ama dilaal, waxana jira estate agents badan Ireland. Waxay ku shaqo leeyihin guri kala ibsiga.

Sidee ayaan u iibsan kara guri ama apartment?

Guri ama apartment waa qaali Ireland Dadka intooda badan waxay ku iibsadaan amaah iyago lacag ka amaahanaya Bangiga ama shirkad dhismo.

Amaahda oo afka ingiriiska lagu yidhaahdo mortgage waxa lagu bixiya 20 ama 30 sannadood. Amahda waxa walibo dul socota lacag aad bil walba bixindoontid.

Intaanu bangigu dadka lacagta amaahin, waxay isku eegayan inay ogaadan inu qofka lacagta amaahanaya bixin kari doono amahdaas. Waxay kalo ay codsan doonan dhibosit ah 10%. Waxaad ka heli karta faahfaahin inta ka badan bangiga (Waxaad eegta qaybta bangiga ku saabsan)

Maxaan cashuur bixin doona?

Lacagta amahda maahe, oo iyaadu joogta ah waxa jira wax laa yidhaahdo fii ama cashur oo ah inaad bixiso marka aad aqal ibsanays

- Stamp Duty – ayaa jira oo ah lacag dowladu aay ka qaado oo ku xidhan qimaha aqalka, iyo haddi aad aqal hore iibsatay (meeshi aay doonta adunka) iyo aqalku intuu leeg yahay. Faahfaahin intaa ka badan waxaad ka heli karta, iyo waliba qimaaha aqalo ka duwan, internet adreska ah “<http://www.revenue.ie>”
- Estate agent – waa dilaalka adiga iyo qofka aqalka iibinaya idin dhexeeya, dilaal walba qimo ayuu leeyahay, marmar qiimaha aqalka ayay ku dhex jirta, laakin mar walba sidaas ma aha.
- Legal fees – waa lacagta cashur ah oo ay qaatan nootayadu. Qimo go'an maha. Way fiican tahay inaad notaayo samaysato ama looyar markaad guri ibsanayso, waa ka cawin karan wuxi sharci ah.

GURYAHA DOWLADA HOOSE

Dowlada hoose guryohoodu waa kale oo loo yaqaano guryaha soshalka waxaanay u banaan yihin dadka sida rasmiga ah u dagan Ireland (waa eegtaa "maxa la yidhaahda qof si rasmi ah u degan" xashida 56) oo bahan guri awoodna aanan u haysan inay ibsadan.

Urrurada guryaha iyo iskaashatooyinka guryuhu way bixiyaan guryaha soshalka ah.

Sidee loo garta qofka la siin karayo guri?

Guryaha waxa loo bixiya sidi ay baahidu u jirto kiraduna waxay ku xidhan tahay inta aad bixin awoodi karta. Haddi aad is leedahay xeer ayaad u leedahay waa inaad ka dalbata dawlada hoose oo eegi doonta, inta qof ee gurigaaga ku nool, lacagta ku soo gasha, guriga aad iminka degan tahay (haddi aad guri degan tahay), guriga sidu yahay iyo waxyaabo kale oo ay ka mid yihin da'da, haddi aad curyaan tahay, xanuun iyo wax yaabo kale oo la mid ah.

Bal ka soo qad haddi lai yeelo dalbashada guriga?

Haddi ay dowlada hoose ku ogolaato waxa lagugu dari doona liska dadka guryaha sugaya, marka guri ayaa lagu siin marka lagu heelo.

Waxaad xeer u leedahay ugu yaraan 7 goor inuu ku eego GP ama dhakhdar dumarka ka umiliya intaanad umulin. Iyo laba goor oo eegmo ah umusha dabadeed, mid ilmaha ah laba wiig dabadeed umusha iyo mid aay ilmaha iyo hooyado leeyihin 6 wiig dabadeed.

Ma inaan lacag bixiya?

Xeer ayaad u leedahay dhakhdar bilash ah markaad xaamilad tahay lacag lagama qaadayo.

XANAANADA ILMAHA DHASHAY

Imahaygu xeer miyu u leeyahay daryeel dhakhdar oo bilash ah?

Ilmahaagu inuu daawo bilaash ah leeyahay waxay ku xidhan tahay inaad adigu leedahay kaadh wuxi ka baxsaan daryeelka ku yaala xashida 58.

Muxu ilmahaygu leeyahay?

Ilmahaagu haddi u dhakhdar ku dhasho badhitaan ayuu xeer u leeyahay. Taas maha wax waalidka la waydinayo inay ogol yihiin iyo in kale.

Imahaygu talaal miyu xeer u leeyahay?

Marku dhasha (ama bisha ugu horaysa noloshiisa) talaalka BCG la yidhaahdo ayaa u wanagsan inu helo. BCG waxay ka ilaalin doonta TB (Tuberculosis). Dhakhdar ayaa siin doona talaalka dhakhdarka dhexdiisa ama meelaha daryeelka caruurta ee dowladu leedahay.

Gormaa ayaa la siin doona talaalka labaad?

Talaalada kale waxa la siiya ilma 12 ama 15 bilood oo ugu horeysa noloshiisa. GP ayaa bilash kugu siin doona waxaana lagu soo diri warqad ku sheegaysa markaad talaalka doonan doontid.

- Markuu ilmahaagu 2, 4, iyo 6 bilood jiro waxaa la siin doona 5-in-1 talaal la yidhaahdo isaga ayaga ilmaha ka ilaalin doona 5 xanuun :Diphtheria, Tetanus, Whooping Cough, Hib (Haemophilus Influenza B) iyo Polio. Waxa laga talaali doona Meningitis C. Waa qorgooyaha.
- Markuu ilmuhu yahay 12 ilaa 15 bilood wuxu heli doona talaal kale oo la yidhaahdo MMR. Talaalkaasi wuxu ka ilaalin doona 3 xanuun (Measle, Mumps, iyo Rubella). Waxa loogu birin doona Hib Booster isla markaas.

Maxaa ilmaha loo talaalaya?

Waxaa ilmaha loo talaala xanuun badan ayay ka ilaalinaysa, way u wanagsan tahay.

Dib ma loo talaali doona marku iskulka galo?

Caruurta inta badan waa la soo talaalay inta yaryar ahayeen laakin waxa jira talaalo markaad weynadaan loogu birin kara:

- Marku ilmuhu gaado 4 ila 5 jir, waxaa loo birin doona 4-in-1 talaal ah (waxay ka ilaalisa diphtheria, Tetanus, Whooping, Cough, Hib iyo Polio) iyo mid labaad oo ah MMR (Measles, Mumps iyo Rubella) marku ilmuhu galo dugsida hoose. Haddi u ilmuhu qaadan waayo ikuulka dhexdiisa HSE ayaa u diyaarin ilmaha sidi dhakhdar loogu talaali laha ama waxaad su'aali GP;
- Marku ilmuhu gaadho fasal 5 ama 6 dhakhdar HSE ayaa siin kara talaalka BCG iyo mid labaad oo ah MMR waliba caruurta kuwa aanan hore loo soo talaalin ee wadan kale ku dhalatay.
- Marka u ilmuhu 11 ila 14 yahay waxay heli doonan talaal ah kii Daxalka iyo waliba diphtheria iskuulka dhexdiisa. Waa barnimij cusub.

WARQAD DHALASHO

Warqad dhalasho muxu u bahanyahay ilmuhu?

2 nooc aya jira oo warqad dhalasho ah – mid kooban iyo mid dheer. Ta kooban waxa loo istacmaala iskoolka marka ilmaha lagu darayo. Wixi kale ee dhinaca dowlada ah, waxa loo isticmaala warqada dhalashada ee dheer.

Imisa weeyan qimaha warqada dhalashadu?

Ta dheer ee faahfaasan ee wax waliba ku qoran yihiin waxa la siiya €10.

Sidee ilmaha waxbarashadiisa loo eegaya?

Imtixaan waxay ka dhigan tahay inuu macalinku qiyaasayo ilmaha waxbarashadiisa wuxu ilmuhu garanayo. Taasi waxay tusaysa ilmaha inuu waxbarashadiisu fiican tahay iyo in kale, ama inu matalan meelo qaar ku fiican yahay iyo in kale.

Sanadkaas Transition Year loo yaqaano waa sanad u dhaxaysa Junior iyo Senior Cycle. Waxaa weeyaan sannad u ilmuhu shaqsiyadiisa dhisayo intii uu cashar kale baran laha.

In some schools, the year is optional, and in others, it is compulsory. The school can advise you on this.

SENIOR CYCLE

Senior Cycle waxa weeyan qaybta labaaad ee dugsiga dhexe. Ardaygu wuxu bilaaba Senior Cycle ama markaas ba ama marku Junior Cycle ka boxo ama sannadka Transitional ka dabadii. (Kor ku qoran)

Cycle laba sannadood ayu socda.

Marka Cycle ka dhiganayaan waxay kala doortaan 3 programss:

- Leaving Certificate Established mid la yidhaahdo
- Leaving Certificate Vocational mid la yidhaahdo
- Leaving Certificate Applied mid la yidhaahdo

The Leaving Certificate Established is the most widely taken programme. Students take at least 5 subjects including Irish (unless exempt). Most students take 6 subjects.
